All Students pay \$100 annual registration fee in addition to their total above tuition. * \$50 off registration fee when enrolled by August 15th

Deposit and registration fee are due at the time of enrollment and are NOT REFUNDABLE for any reason.

Deposit IS included in the total tuition but does NOT change the # of payments or the payment amount as stated in the above payment plans.

Students registered after the start of the school year, must pay FULL (\$100) registration fee with program tuitions prorated based on enrollment date.

Deposits will be prorated to \$125 for students enrolling AFTER December 1, 2010.

Monthly payments in "Payment Plan A" are due by the 10th of each month from September 2010 -April 2011

Quarterly payments in "Payment Plan B" are due: September 10, 2010, November 10, 2010, February 10, 2011 and May 10, 2011

Semester payments in "Payment Plan C" are due: September 10, 2010 and February 10, 2011

* Students in more than one College Prep COMPANY (ie: Music & Stage or Music & Jazz) will be charged the above COMPANY tuition for EACH COMPANY

** College Prep students (7th-12th) wishing to add studies (ie: Music plus Stage) may do so at the above College Prep tuition plus the above Additional College Prep Core studies tuition. Additional College Prep CORE studies do NOT include a second private lesson.

Families with multiple children enrolled: After 1st child's registration fee and deposit are paid, these fees (registration & deposit) will be waived for subsequent children enrolled.
